After that, you will see the list of BTP Administrators and BTP Authorized Users of the BTP Business.

BTP Administrator is given right to access all online services while BTP Authorized Users can access the online services assigned by the BTP Administrators.

- You can select a specific BTP Administrator or BTP Authorized User record to view his/her details.
- 2 Click "Add BTP Administrator" or "Add BTP Authorized User" to add user(s) to the business account.

(Each BTP Business can appoint no more than five BTP Administrators while the number of BTP authorized users is unlimited.)

- 3 Click "Remove" to delete any existing BTP Administrator or BTP Authorized User.
  - By clicking "Select BTP Business", you can switch to another Business to manage its BTP Administrator(s) and Authorized User(s).
